Notes:

- i) **Evidence of Home Address**—please provide council tax bill, formal lease agreement or other documentation of occupation
- Evidence of New Home Address—If parents are moving house, the school will ask for evidence of the move, before considering any application for a place. Documentary evidence in the form of a solicitor's letter to confirm exchange of contracts, a rental agreement for at least a period of six months will be required (Armed Forces personnel are exempt). If you are returning from elsewhere, to live in a home that you own, we will require evidence to show that you have returned. We will also ask for evidence that any previous house owned has been sold or is being sold. We would not accept an address where the one given is that of a second home with the main home being elsewhere. If there are two or more homes, we will check which is the main home, and may refuse to base an allocation of a place on an address which might be considered only temporary. Nor would we accept an address where the child was resident other than with a parent or carer unless this was part of a fostering or formal care arrangement. We would not normally accept an address where only part of a family had moved, unless connected with a divorce or permanent separation arrangement, in which case we would require proof.
- iii) **Exceptional medical or social reasons:** These will only be considered if evidence is provided. If you think your child has a disability as defined in the Equality Act 2010 and you have chosen our school with this in mind, please give us more details.
- iv) A Statement of SEN or ECH is a document written by the local authority detailing the needs that a child has in learning at school, and the measures which the school will take to help them.
